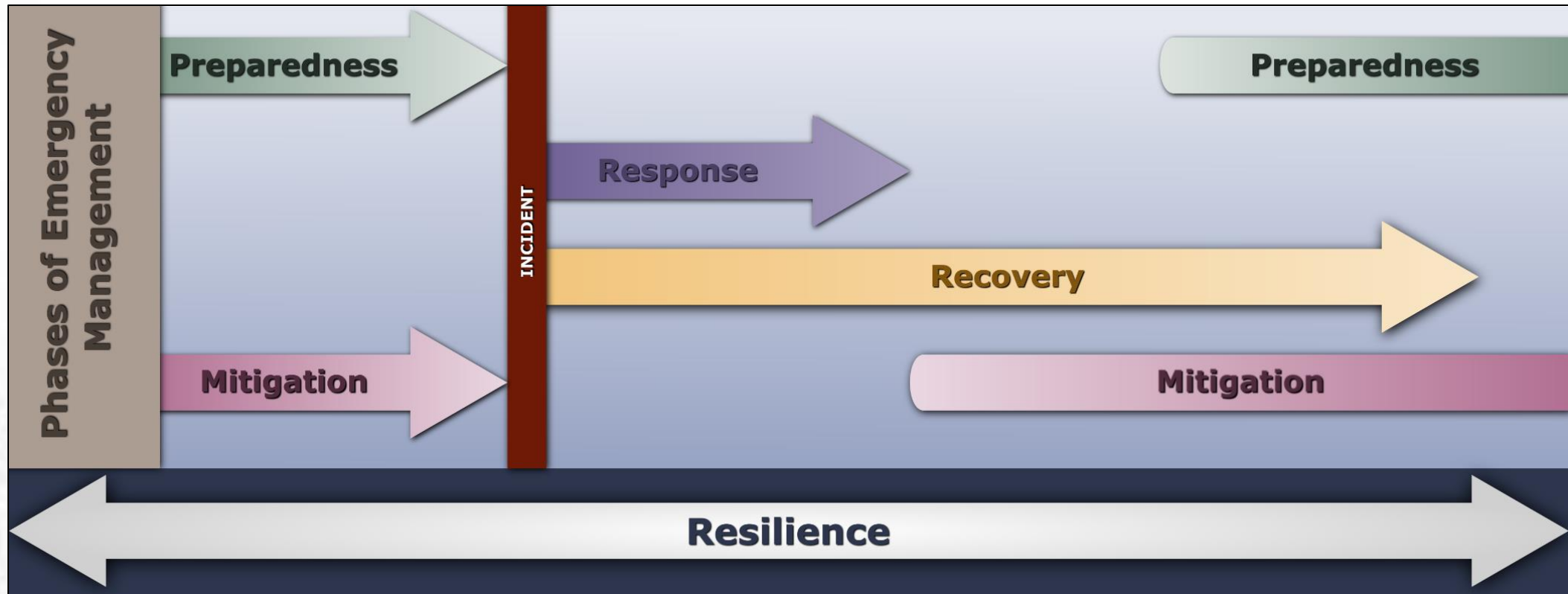
1. Bring people together

We take a whole city approach to emergency management.

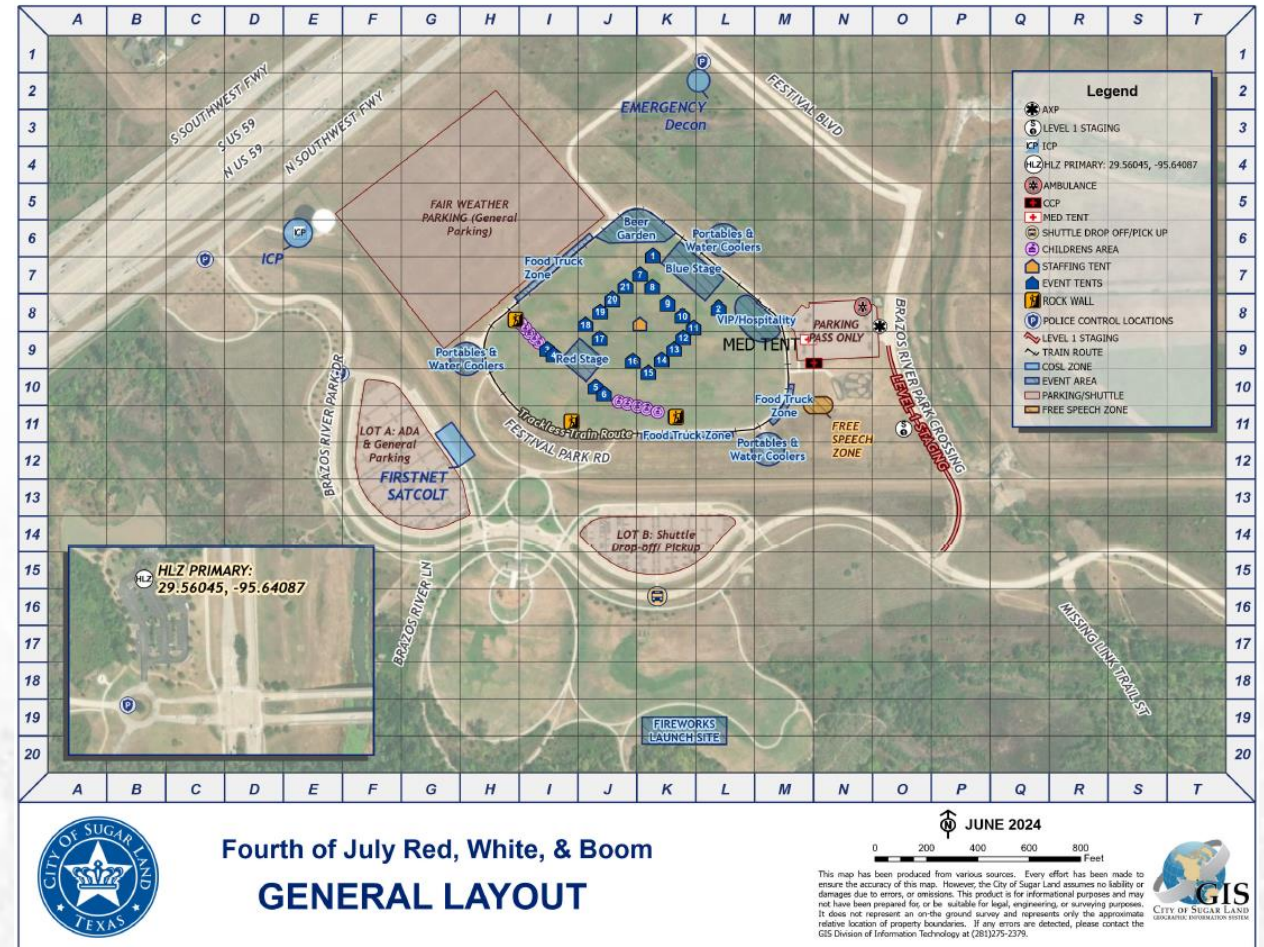


PHASES OF EMERGENCY MANAGEMENT



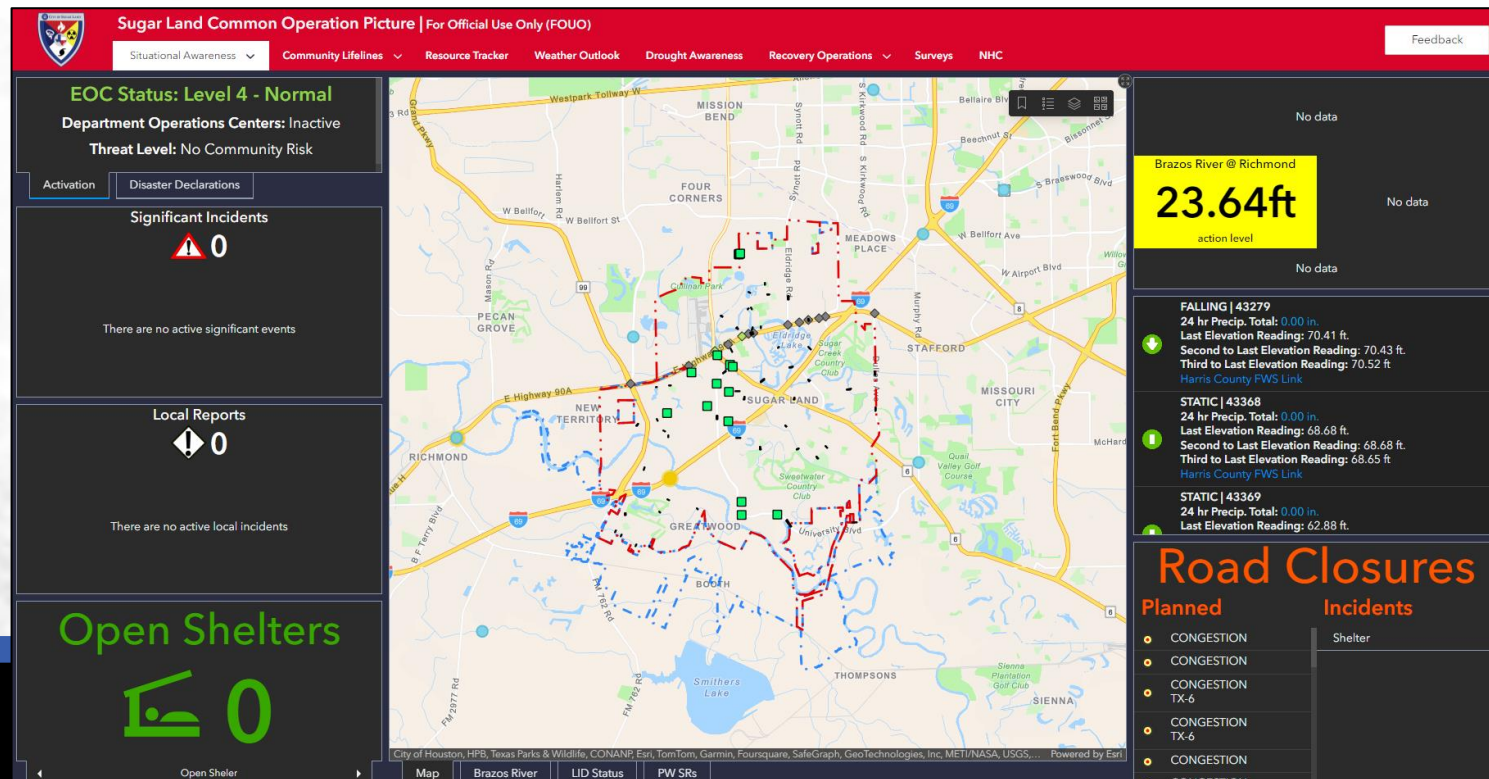
WHERE DOES GIS FIT IN?

- Survey 123 and Quick Capture (*again, we love a good survey*)
- Identifying mapping needs



COSL EOC - Activity Log (ICS 214)

The Activity Log (ICS-214) is used by Team Leaders, Group Supervisors, Unit Leaders, Branch Directors, Command Staff and Section Chiefs to document key activities that occurred during an operational period. This report is due by 1800 daily.

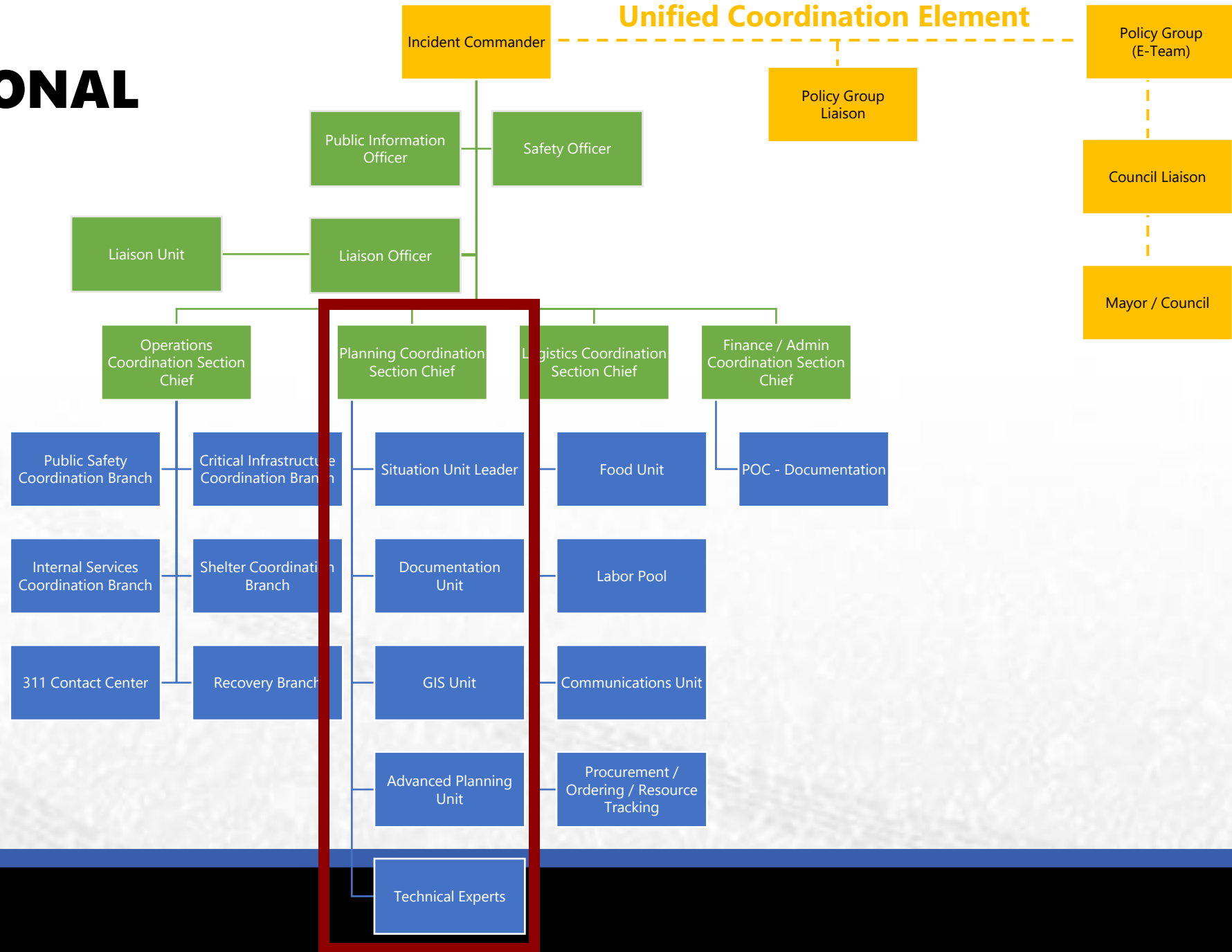

EOC ORGANIZATIONAL CHART



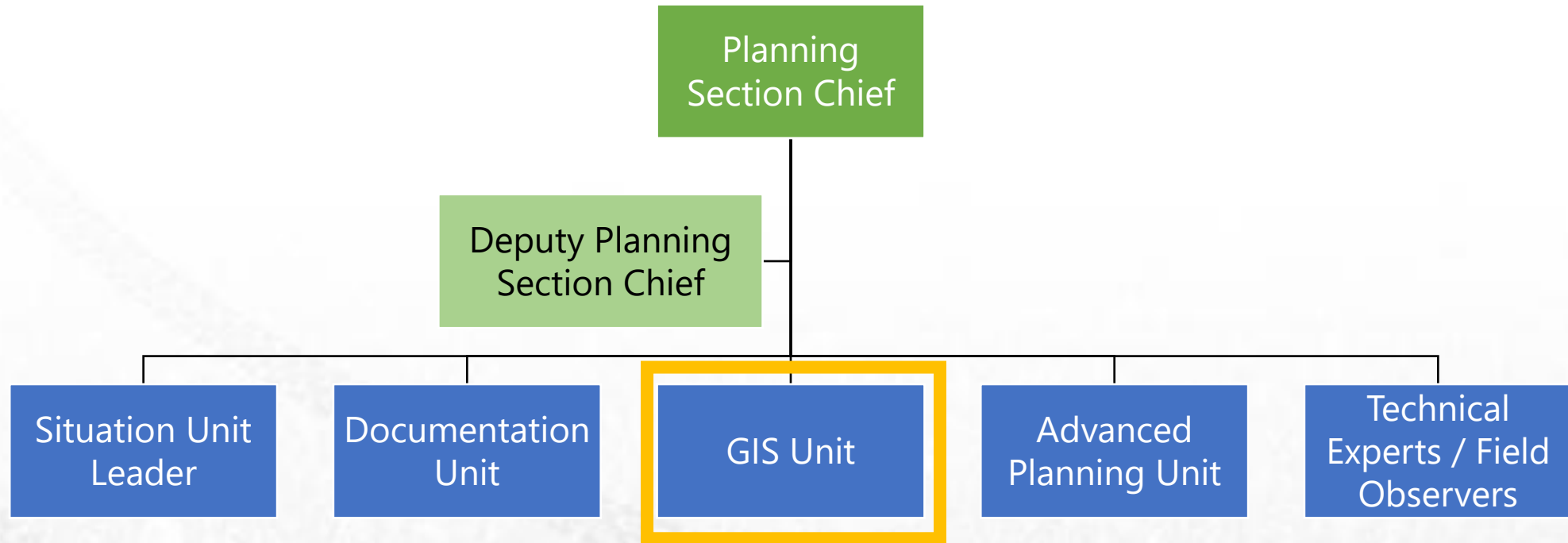
PLANNING SECTION CRITICAL TASKS

- Maintain situational awareness by collecting and managing relevant operational data.
- Process and prioritize data into intelligence.
- Manage the preparation of the incident action plan.
- Provide feedback to the Incident Commander and Operations Section Chief to support operational decision making.

The job of the Planning Section is to verify, synthesize, and communicate a clear picture to the organization/ decision makers!

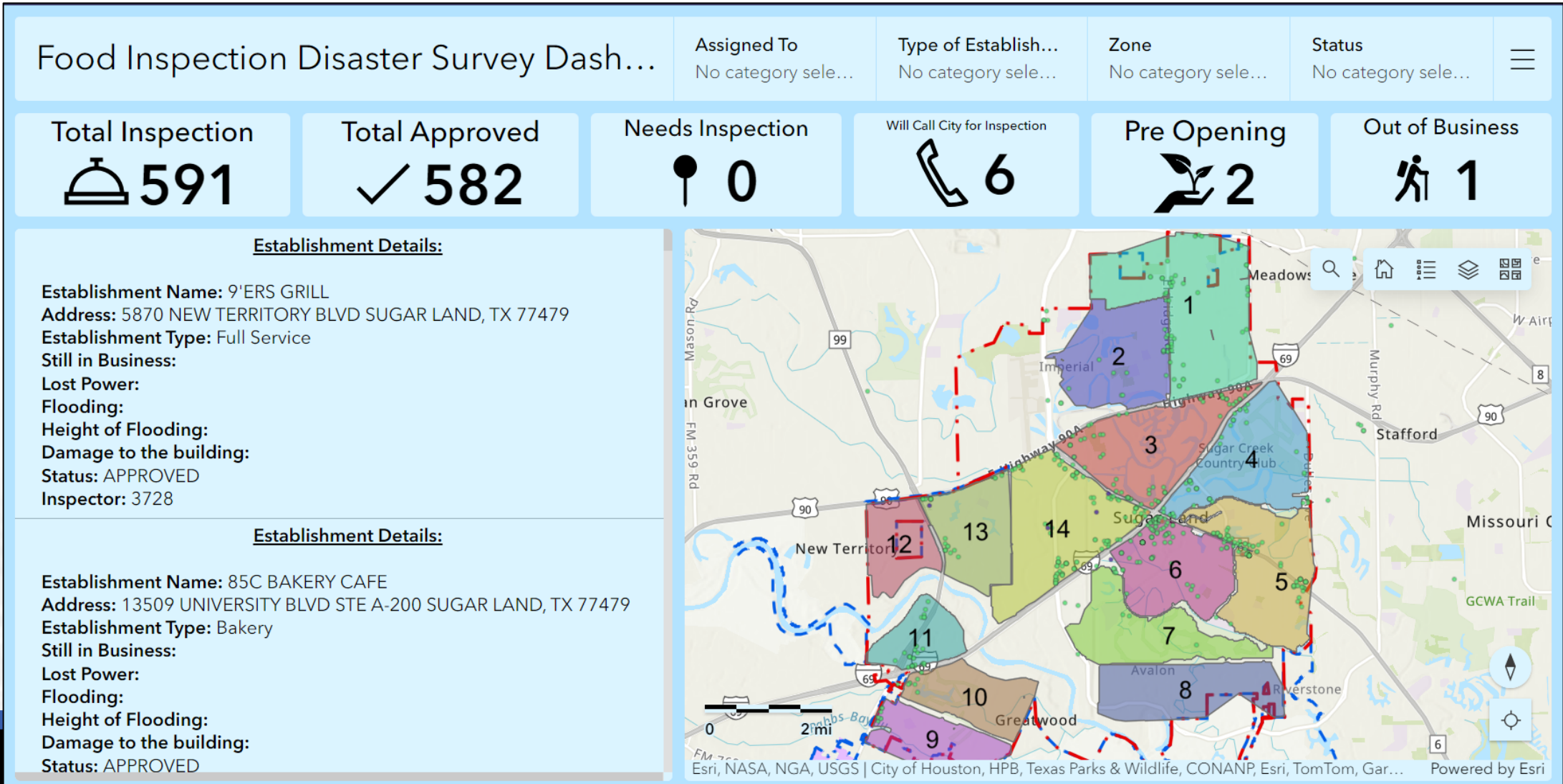
